

**Carahsoft Rider to Manufacturer End User License Agreements  
(for U.S. Government End Users)**

1. **Scope.** This Carahsoft Rider and the Manufacturer End User License Agreement (EULA) establish the terms and conditions enabling Carahsoft to provide Software and Services to U.S. Government agencies (the "Client" or "Licensee").
2. **Applicability.** The terms and conditions in the attached Manufacturer EULA are hereby incorporated by reference to the extent that they are consistent with Federal Law (e.g., the Anti-Deficiency Act (31 U.S.C. § 1341(a)(1)(B)), the Contracts Disputes Act of 1978 (41 U.S.C. § 601-613), the Prompt Payment Act, the Anti-Assignment statutes (31 U.S.C. § 3727 and 41 U.S.C. 15), 28 U.S.C. § 516 (Conduct of Litigation Reserved to Department of Justice (DOJ), and 28 U.S.C. § 1498 (Patent and copyright cases)). To the extent the terms and conditions in the Manufacturer's EULA are inconsistent with the Federal Law (*See FAR 12.212(a)*), they shall be deemed deleted and unenforceable under any resultant orders under Carahsoft's contract #GS-35F-0119Y, including, but not limited to the following:
  - (a) **Contracting Parties.** The Government customer (Licensee) is the "Ordering Activity", "defined as an entity authorized to order under GSA contracts as set forth in GSA ORDER 4800.2G ADM, as may be revised from time to time. The Licensee cannot be an individual because any implication of individual licensing triggers the requirements for legal review by Federal Employee unions. Conversely, because of competition rules, the contractor must be defined as a single entity even if the contractor is part of a corporate group. The Government cannot contract with the group, or in the alternative with a set of contracting parties.
  - (b) **Changes to Work and Delays.** Subject to GSAR Clause 552.243-72, Modifications (Federal Supply Schedule) (July 200 0) (Deviation I 2010) (AUG 1987), and 52.212 -4 (f) Excusable delays. (JUN 2010) regarding which the GSAR and the FAR provisions shall take precedence.
  - (c) **Contract Formation.** Subject to FAR Sections 1.601(a) and 43.102, the Government Order must be signed by a duly warranted contracting officer, in writing. The same requirement applies to contract modifications affecting the rights of the parties. All terms and conditions intended to bind the Government must be included within the contract signed by the Government.
  - (d) **Audit.** During the term of this Agreement: (a) If Ordering Activity's security requirements included in the Order are met, Manufacturer or its designated agent may audit Ordering Activity's facilities and records to verify Ordering Activity's compliance with this Agreement. Any such audit will take place only during Ordering Activity's normal business hours contingent upon prior written notice and adherence to any security measures the Ordering Activity deems appropriate, including any requirements for personnel to be cleared prior to accessing sensitive facilities. Carahsoft on behalf of the Manufacturer will give Ordering Activity written notice of any non-compliance, including the number of underreported Units of

Software or Services ("Notice"); or (b) If Ordering Activity's security requirements are not met and upon Manufacturer's request, Ordering Activity will run a self-assessment with tools provided by and at the direction of Manufacturer ("Self-Assessment") to verify Ordering Activity's compliance with this Agreement.

- (e) **Termination.** Clauses in the Manufacturer EULA referencing termination or cancellation the Manufacturer's EULA are hereby deemed to be deleted. Termination shall be governed by the FAR 52.212-4 and the Contract Disputes Act, 41 U.S.C. §§ 601-613, subject to the following exceptions:

Carahsoft may request cancellation or termination of the License Agreement on behalf of the Manufacturer if such remedy is granted to it after conclusion of the Contracts Disputes Act dispute resolutions process referenced in Section Q below or if such remedy is otherwise ordered by a United States Federal Court..

- (f) **Consent to Government Law / Consent to Jurisdiction.** Subject to the Contracts Disputes Act of 1978 (41. U.S.C §§ 7101-7109) and Federal Tort Claims Act (28 U.S.C. §1346(b)). The validity, interpretation and enforcement of this Rider will be governed by and construed in accordance with the laws of the United States. In the event the Uniform Computer Information Transactions Act (UCITA) or any similar federal laws or regulations are enacted, to the extent allowed by law, it will not apply to this Agreement, and the governing law will remain as if such law or regulation had not been enacted. All clauses in the Manufacturer EULA referencing equitable remedies are deemed not applicable to the Government order and are therefore deemed to be deleted.
- (g) **Force Majeure.** Subject to FAR 52.212 -4 (f) Excusable delays. (JUN 2010). Unilateral Termination by the Contractor does not apply to a Government order and all clauses in the Manufacturer EULA referencing unilateral termination rights of the Manufacturer are hereby deemed to be deleted.
- (h) **Assignment.** All clauses regarding Assignment are subject to FAR Clause 52.232-23, Assignment of Claims (JAN 1986) and FAR 42.12 Novation and Change-of-Name Agreements, and all clauses governing Assignment in the Manufacturer EULA are hereby deemed to be deleted.
- (i) **Waiver of Jury Trial.** All clauses referencing waiver of Jury Trial are subject to FAR Clause 52.233-1, Disputes (JUL. 2002), and all clauses governing waiver of jury trial in the Manufacturer EULA are hereby deemed to be deleted.
- (j) **Customer Indemnities.** All Manufacturer EULA clauses referencing Customer Indemnities are hereby deemed to be deleted.
- (k) **Contractor Indemnities.** All Manufacturer EULA clauses that (1) violate DOJ's right (28 U.S.C. 516) to represent the Government in any case and/or (2) require that the Government give sole control over the litigation and/or settlement, are hereby deemed to be deleted.
- (l) **Renewals.** All Manufacturer EULA clauses that violate the Anti-Deficiency Act (31 U.S.C. 1341, 41 U.S.C. 11) ban on automatic renewal are hereby deemed to be deleted.

- (m) Future Fees or Penalties.** All Manufacturer EULA clauses that violate the Anti-Deficiency Act (31 U.S.C. 1341, 41 U.S.C. 11), which prohibits the Government from paying any fees or penalties beyond the Contract amount, unless specifically authorized by existing statutes, such as the Prompt Payment Act, or Equal Access To Justice Act 31 U.S.C. 3901, 5 U.S.C. 504 are hereby deemed to be deleted.
- (n) Taxes.** Taxes are subject to FAR 52.212-4(k), which provides that the contract price includes all federal, state, local taxes and duties.
- (o) Third Party Terms.** Subject to the actual language agreed to in the Order by the Contracting Officer. Any third party manufacturer will be brought into the negotiation, or the components acquired separately under Federally-compatible agreements, if any. Contractor indemnities do not constitute effective migration.
- (p) Installation and Use of the Software.** Installation and use of the software shall be in accordance with the Rider and Manufacturer EULA, unless an Ordering Activity determines that it requires different terms of use and Manufacturer agrees in writing to such terms in a valid task order placed pursuant to the Government contract.
- (q) Dispute Resolution and Venue.** Any disputes relating to the Manufacturer EULA and to this Rider shall be resolved in accordance with the FAR, and the Contract Disputes Act, 41 U.S.C. §§ 7101-7109. The Ordering Activity expressly acknowledges that Carahsoft, on behalf of the Manufacturer, shall have standing to bring such claim under the Contract Disputes Act.
- (r) Limitation of Liability: Subject to the following:**
- Carahsoft, Manufacturer and Ordering Activity shall not be liable for any indirect, incidental, special, or consequential damages, or any loss of profits, revenue, data, or data use. Further, Carahsoft, Manufacturer and Ordering Activity shall not be liable for punitive damages except to the extent this limitation is prohibited by applicable law. This clause shall not impair the U.S. Government's right to recover for fraud or crimes arising out of or related to this Government Contract under any federal fraud statute, including the False Claims Act, 31 U.S.C. §§ 3729-3733.
- (s) Advertisements and Endorsements.** Unless specifically authorized by an Ordering Activity in writing, such use of the name or logo of any U.S. Government entity is prohibited.
- (t) Public Access to Information.** Manufacturer agrees that the EULA and this Rider contain no confidential or proprietary information and acknowledges the EULA and this Rider will be available to the public.
- (u) Confidentiality.** Any provisions that require the Licensee to keep certain information confidential are subject to the Freedom of Information Act, 5 U.S.C. §552, and any order by a United States Federal Court.

## WHITECANYON SOFTWARE END USER LICENSE AGREEMENT

**THIS SOFTWARE LICENSE AGREEMENT (THE "LICENSE") IS A LEGAL AGREEMENT BETWEEN WHITECANYON SOFTWARE, INC. ("WHITECANYON") AND YOU (EITHER AN INDIVIDUAL OR AN ENTITY). BY CLICKING THE "ACCEPT" BOX OR BY DOWNLOADING, INSTALLING, COPYING OR OTHERWISE USING THE SOFTWARE, YOU REPRESENT (I) THAT YOU HAVE BEEN AUTHORIZED TO ACCEPT THESE TERMS ON BEHALF OF THE CUSTOMER (THE ENTITY ON WHOSE BEHALF YOU ARE ACTING, IN WHICH EVENT "YOU" AND "YOUR" SHALL REFER TO YOU AND SUCH ENTITY, AS THE CASE MAY BE), OR (II) THAT YOU INTEND TO BE PERSONALLY BOUND TO THE TERMS OF THIS AGREEMENT AS THE CUSTOMER. IF YOU ARE NOT SO AUTHORIZED OR DO NOT INTEND TO BE PERSONALLY BOUND, THEN WHITECANYON IS UNWILLING TO LICENSE THE SOFTWARE, YOU ARE NOT PERMITTED TO DOWNLOAD, INSTALL, COPY OR USE THE SOFTWARE, AND YOU SHOULD RETURN IT TO THE ORIGINAL SOURCE FOR A REFUND. IF YOU ACCEPT THESE TERMS ON BEHALF OF AN ENTITY, YOU MAY USE THE SOFTWARE ONLY ON BEHALF OF SUCH ENTITY. IF YOU INTEND TO BE PERSONALLY BOUND, USE OF THE SOFTWARE IS LIMITED TO YOUR PERSONAL USE.**

**License.** You have licensed or been officially authorized by WhiteCanyon to install and use WipeDrive. The following terms shall apply:

- The Software is provided in and is licensed for use in object-code form only.
- You may not reverse assemble, reverse compile, translate or otherwise attempt to create the source code from the Software or create derivative works of the Software or any portion thereof, including for reasons of error correction or interoperability, except to the extent this prohibition is limited by law.
- Licensee is entitled to receive Software updates, upgrades and technical support for the duration of the Term.
- You may not use, transmit, distribute, copy, modify, or alter the Software except as expressly provided in this License.
- You may not rent, lease, license, grant a security interest in, or otherwise transfer rights to the Software without written permission from WhiteCanyon.
- You may not remove or alter any trademark, logo, copyright or other proprietary notices, legends, symbols or labels in the Software.

**Term.** **This License shall continue so long as You use the Software in compliance with this License and any other Agreements (including, but not limited to, Sales Quotes, Purchase Orders and/or other written agreements) between WhiteCanyon and You as to term limitations and usage limitations. Should You breach any of its obligations, this License shall automatically terminate, and You agree to destroy all copies of the Software and all materials provided for or with the Software. You may terminate this License at any time by deleting and destroying all copies or returning them to WhiteCanyon.**

**Title.** WhiteCanyon retains all proprietary rights and title to the Software and any modifications, including copyrights, trade names and trademarks, and no ownership of any part of the Software is hereby transferred to You. You agree to exercise due care and diligence under this License to protect the interests and rights of WhiteCanyon and its suppliers.

**Security.** You understand and agree that the Software contains trade secrets belonging to WhiteCanyon, and will take all reasonable steps to protect its confidentiality. You acknowledge that the Software is the property of WhiteCanyon and contains confidential information. You agree that You will not provide a copy of the Software nor divulge any details of it to any person without the prior consent in writing of WhiteCanyon, provided that You may permit Your employees to access Your copy subject to the terms hereof.

**Backup.** You may make the number of copies of the Software deemed necessary and to distribute such copies solely to employees, or authorized agents and solely for internal use by such. Licensee may also make a copy of the Software for archival purposes. Any and all copies of the Software made are fully subject to the terms of this License.

**Term.** This License shall continue so long as You use the Software in compliance with this License and any other Agreements (including, but not limited to, Sales Quotes, Purchase Orders and/or other written agreements) between WhiteCanyon and You as to term limitations and usage limitations. Should You breach any of its obligations, this License shall automatically terminate, and You agree to destroy all copies of the Software and all materials provided for or with the Software. You may terminate this License at any time by deleting and destroying all copies or returning them to WhiteCanyon.

**Limited Warranty and Limitation of Warranties and Liability.** (a) WhiteCanyon warrants to the original purchaser of a license for the Software, (i) that the Software, will perform substantially in accordance with the accompanying documentation and (ii) that the Software is properly recorded on the disk media. This Limited Warranty extends for ninety (90) days from the date of purchase. (b) This Limited Warranty does not apply to any Software that has been altered, damaged, abused, misapplied, or used other than in accordance with this License Agreement and any instructions included on the Software and the accompanying documentation. (c) WhiteCanyon's entire liability and Licensee's exclusive remedy under this Limited Warranty shall be the repair or replacement of the any Software that fails to conform to this Limited Warranty or, at WhiteCanyon's option, return of the price paid for the Software. WhiteCanyon shall have no liability under this Limited Warranty unless the Software is returned to WhiteCanyon or its authorized representative, with a copy of receipt, within the warranty period. Any replacement Software will be warranted for the remainder of the original warranty period or thirty (30) days whichever is longer. (d) THIS WARRANTY IS IN LIEU OF AND EXCLUDES ALL OTHER WARRANTIES NOT EXPRESSLY SET FORTH HEREIN, WHETHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT, OR WARRANTIES ARISING FROM USAGE OF TRADE OR COURSE OF DEALING. (e) THIS WARRANTY GIVES LICENSEE SPECIFIC LEGAL RIGHTS; LICENSEE MAY HAVE OTHERS WHICH VARY FROM STATE TO STATE.

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT (INCLUDING NEGLIGENCE) (I) SHALL WHITECANYON OR ITS SUPPLIERS BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT, CONSEQUENTIAL OR PUNITIVE DAMAGES WHATSOEVER (INCLUDING WITHOUT LIMITATION, DAMAGES FOR LOSS OF BUSINESS PROFITS, LOSS OF BUSINESS INFORMATION OR OTHER PECUNIARY LOSS) ARISING OUT OF THE USE OR THE INABILITY TO USE THE SOFTWARE, EVEN IF WHITECANYON HAS BEEN ADVISED OF THE POSSIBILITY FOR SUCH DAMAGES, OR (II) SHALL WHITECANYON'S AGGREGATE LIABILITY IN CONNECTION WITH THE SOFTWARE OR USE OF THE SOFTWARE EXCEED THE AMOUNT PAID BY YOU TO WHITECANYON FOR THE PARTICULAR SOFTWARE WITH RESPECT TO WHICH SUCH LIABILITY AROSE.

SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF SPECIAL, INCIDENTAL, INDIRECT, CONSEQUENTIAL OR PUNITIVE DAMAGES OR THE LIMITATION OF LIABILITY IN CERTAIN SITUATIONS, SO THE ABOVE EXCLUSIONS OR LIMITATIONS MAY NOT APPLY TO YOU IN ALL INSTANCES.

**Additional Warranty.** WhiteCanyon shall indemnify, defend, and hold Customer harmless from all third party claims and lawsuits which are caused by WhiteCanyon infringement of a United States patent, United States copyright or trade secret. WhiteCanyon indemnification obligation is subject to: (i) Customer providing WhiteCanyon with prompt written notice of any claim or lawsuit, (ii) WhiteCanyon having sole control of the defense and all negotiations for settlement or compromise thereof and (iii) Customer reasonably cooperating in the defense of such claim or lawsuit. WhiteCanyon agrees to pay all settlements entered into by WhiteCanyon, judgments finally awarded against Customer, and all attorneys' fees and expenses for counsel hired by WhiteCanyon. Customer may elect to participate in any such action with counsel of its own choice and at its own expense. In the event Customer is precluded by a court of competent jurisdiction from using a Product as a result of WhiteCanyon infringement of any such patent, copyright, or trade secret, WhiteCanyon may, in its reasonable discretion, (i) obtain the right to use the Product for the Customer, or (ii) replace or modify the Product so that it no longer infringes. If neither (i) or (ii) above is commercially feasible, then in WhiteCanyon's reasonable discretion, WhiteCanyon may terminate the license for the affected Product and issue Customer a pro-rata refund of the fees paid by Customer for the infringing Product. This section states WhiteCanyon's entire liability with regard to infringement claims.

**Governing Law and Forum Selection.** The validity of this License and the rights, obligations and relations of the parties shall be construed and determined in accordance with the laws of the State of Utah, United States of America, without giving effect to the principles of conflict or choice of law of such State. You acknowledge that any action or suit brought to enforce any right or remedy of this Agreement shall be subject to the exclusive jurisdiction and venue of federal and state courts in Utah. The original of this License has been written in English. The parties hereto waive any statute, law, or regulation that might provide an alternative law or forum or to have this Agreement written in any language other than English. WhiteCanyon and You exclude the United Nations Convention on Contracts for the International Sale of Goods from this License.

**U.S. Government Restricted Rights.** The Software and any accompanying manuals are "commercial items" (as defined in 48 C.F.R. 2.101) that were developed at private expense, are not in the public domain, and are provided to any agency, contractor or subcontractor of the U.S. Government (at any tier) subject to the maximum restrictions on use permitted by FAR 52.227-19 for civilian agencies and DFARS 227.7202-3(a) (Jan. 1, 2000) for military agencies, or successor regulations. Thus, to the maximum extent permitted by law the U.S. Government and any intermediate buyers obtain only those rights specified herein. **Export Controls.** In accordance with the U.S. Department of Commerce, Export Administration Regulations (EAR): "These commodities, technology or software were exported from the United States in accordance with the Export Administration Regulations. Diversion contrary to U.S. law is prohibited."

None of the Software or underlying information or technology may be downloaded or otherwise exported or reexported (i) into (or to a national or resident of) Cuba, Iraq, Libya, Sudan, North Korea, Iran, Syria or any other country to which the U.S. has embargoed goods; or (ii) to anyone on the U. S. Treasury Department's list of Specially Designated Nationals or the U.S. Commerce Department's Table of Denial Orders. By downloading or using the Software, you agree to the foregoing and represent and warrant that you are not located in, under the control of, or a national or resident of any such country or on any such list. In addition, you are responsible for complying with any local laws in your jurisdiction which may affect your right to import, export or use the Software, and represent that you have complied with any regulations or registration procedures required by applicable law to make this license enforceable.

**Miscellaneous.** You may not assign or transfer in any way this License, any rights or obligations thereto, the Software or any modifications thereto without the prior written consent of WhiteCanyon. If any provision of this License is held to be excessively broad as to scope, activity, subject or otherwise so as to be unenforceable at law, such provision shall be constructed by limiting or reducing it so as to be enforceable to the maximum extent compatible with the applicable law as it shall then appear. This License represents the entire understanding between the parties with respect to its subject matter and merges all prior written and oral communications. This License may not be modified except by a written agreement signed by authorized representatives of both parties. A waiver by either party of its rights hereunder shall not be binding unless contained in a written agreement signed by an authorized representative of the party waiving its rights. The non-enforcement or waiver of any provision on one occasion shall not constitute a waiver of such provision on any other occasions unless expressly so agreed in writing.
